

## GUIDELINES for the AUTHORS

Manuscripts should be one and half-spaced, with pages numbered. The title page should include the names, titles and affiliations of all authors and e-mail; Limit the number of authors to three or four. A word count is mandatory; articles should be no longer than 7,000 words (not including references and footnotes). Please include a data based, structured abstract of no more than 250 words (also not included in the total word count).

Use active voice when writing the text. Stick to plain English, and avoid jargon. Describe the study's methodology clearly and simply; dispense with arcane acronyms.

The maximum number of tables and other graphics is six or seven. Place each table and chart at the end of the document and provide data points for all as

While all data and factual observations need a **reference**, reference lists are not meant to be comprehensive bibliographies; they should indicate that you are familiar with the relevant literature. It is intended to follow a reference style based on the citation-sequence (Alphabetical order). References are given as Bhatia et al., (1995) or (Population Council, 1999; Sadhu et al., 2000) in the text, and are listed Alphabetical order at the end of the document after conclusion of the article.

Footnotes and references are separate elements and should not be intermingled. Footnotes are appropriate for parenthetical or explanatory information that cannot be smoothly accommodated in the text. To distinguish them from references, designate them with proper numbers. Please do not use computer automatic numbering functions for either references or footnotes; type them at the end .

Acknowledgements should include funding information, as well as the disclosure of any employment, appointments or financial arrangements that might be perceived as a conflict of interest. Acknowledgements should not be used to thank anonymous reviewers, study participants or coworkers who provided no out-of-the-ordinary technical or intellectual expertise.
